INTERNAL REGULATIONS CAMPSITE: LE PONTET

1. Conditions for Admission:

To enter and settle in the field, you must have been authorised to do so by the management or their representative.

Staying at the campsite du Pontet implies you accept these regulations and agree to comply with them.

Any offence may result in the offender's expulsion with recourse to the police if necessary.

2. Police Formalities:

Anyone planning to stay at least one night on the campground must first present their identity documents to the management.

3. Pitching-up:

The tent or caravan and all equipment must be installed in the location indicated by the management.

Each pitch must be kept in perfect condition of constant cleanliness; the removal of combustible materials is the responsibility of the pitch's occupant, including the underside of caravans or mobile homes.

Do not delimit a pitch by personal means, nor dig into the ground without the prior consent of the campsite owner. Any damage committed in this regard will be charged to the perpetrator.

The pitches are only intended for leisure use to the exclusion of all industrial, commercial, craft or, in general, professional activities.

4. Reception Desk:

The hours of the reception desk vary according to seasonality and are displayed at the reception desk.

At the reception desk you will find all the information about camping services, information on shopping, sports facilities, tourist attractions in the area, and a variety of useful addresses.

5. Fees:

Fees are payable at the reception desk. Their amount is determined by the price list. They are based on the number of nights spent on the campsite.

Campers are invited to notify the reception desk the day before their departure date.

Campers intending to leave before the opening time of the reception desk must pay their fees the day before.

6. Noise and Silence:

Campers are urged to avoid noise and conversations which might disturb their neighbours. Sound equipment must be adjusted accordingly. Car doors and boots must be closed as quietly as possible.

Dogs and other animals must not be left to roam free or be locked up in the absence of their legally responsible owners.

Silence must be complete between 22:00 and 7:00.

7. Guests:

Guests may be admitted to the campsite and are the responsibility of the campers who receive them.

8. Traffic and Parking Vehicles:

Inside the campsite, vehicles maximum speed is 10 km/h.

Only vehicles belonging to campers staying here may circulate in the campsite. No parking on pitches usually occupied by camping shelters. Parking must not hinder traffic or prevent new arrivals settling.

To avoid damaging the roads, only vehicles equipped with rubber tyres may travel on the campsite's tracks; in the event of damage, repairs will be at the expense of the responsible party.

9. Facilities' Maintenance and Appearance:

All must respect the cleanliness, hygiene and appearance of the campsite. It is forbidden to dispose of wastewater on the ground or in the gutters.

Wastewater tanks must be emptied in the facilities provided.

Household waste, residual waste, and paper must be deposited in the bins provided.

The campsite is equipped with showers, washbasins, laundry and dishwashing facilities, so do not to use these wash facilities for purposes other than those assigned to them.

Clothes washing machines are available.

Parents are asked to accompany young children to the sanitary blocks. Care must be taken with plants and flowers. Do not hammer nails into trees, cut branches, or plant anything.

Do not delimit your pitch by personal means, or by digging into the ground. Any damage to the vegetation, fencing, ground or camping facilities will be charged to the perpetrator.

10. Safety

Fire:

Open fires with wood or charcoal, are strictly forbidden. Freestanding barbecues are only allowed if management have agreed. Stoves should be kept in perfect working order and should not be used in a tent or near a car. Alcohol or petrol stoves are strictly prohibited.

Stoves must be kept in good working order.

Pitches must be cleaned in accordance with Article 14 of the Forest Code Decree.

Any breach will result in immediate expulsion from the campsite.

Fire extinguishers are available to all. In case of fire, notify the management immediately.

Each pitch occupant is asked to bring a multipurpose powder fire extinguisher in good working order, which must be checked annually, as well as a first aid kit.

A first aid kit is available at the reception desk.

Theft:

Management is not a custodian of the equipment inside the campsite and cannot be held liable in the event of theft or damage.

Report the presence of any suspicious person in the campsite to management immediately.

Falling trees

Management declines any liability in the event of falling trees or branches on caravans or people.

11. Games:

No violent or disruptive games may be organised near any of the facilities.

12. Storage pitch:

Equipment should not be left unattended on the premises without management's permission, and if agreed, only in a designated space. A fee will be payable, as displayed at the reception desk.

Management shall not be liable for damage to caravans, including skylights and awnings, for any reason whatsoever.

13. Electricity:

For the caravans' electricity distribution, amperage is calibrated at 6A, 8A or 10A. Each caravan must be connected by means of a cable compliant with the standards in force (mandatory earthing) and will be responsible for its own equipment in the event of any fault and accident that may result.

Each user is required to use properly insulated electrical equipment that complies with IP67. In particular, cables must resist the dangers of mechanical deterioration and immersion and mobile plugs and sockets must be impervious to immersion.

As an additional safety measure, it is recommended that a minimum 2.5 mm2 extension cord diameter be used for any connection.

14. Caravans:

Caravans must remain mobile at all times, specifically with:

- wheels with rubber tires,
 - means of towing,
- regulatory braking and signalling system.

To this end, structures such as awnings, fences, terraces should not be put up if their fixed and sturdy nature could cause the caravans to lose their qualification as a caravan. Any installation made in contravention of the above provisions must be immediately removed, without prejudice to the campsite owner terminating the rental agreement for non-compliance with the internal regulations, all of which must be obeyed.

15. Campsite owner:

The owner is responsible for order and the good upkeep of the campsite and has a duty to punish serious breaches of the regulations and, if necessary, to expel their perpetrators.

A complaints book is available to campers. Complaints will only be considered if they are signed, dated, described as accurately as possible, and refer to relatively recent events.

In the interest of all, you are requested to comply with these regulations.
